

STRUCTURES

- Layout of the disposition of structures and list of planned installations
- Structural designs and notes of the calculations for temporary installations and/or certificate of static suitability of temporary structures
- Periodic report of structures verification
- Fire reaction certificate and declarations of conformity regarding the products employed (ex: tents, chairs, flooring, etc.) - for definition see NOTA 2

TEMPORARY SET-UP

- Layout of the disposition of structures and list of planned installations
- Fire reaction certificate and declarations of conformity regarding the products employed (ex: tents, chairs, flooring, etc.) - for definition see NOTA 2

PLANT BUILDING

- Scheme of the plants installed, data sheet of products and materials employed and their declaration of conformity
- Indication of presence, type and position of gas systems with canisters
