



## REPORT OF WORKING AREA ENTRUSTING

OGGETTO: Area entrusting about activity of \_\_\_\_\_ in area currently available for S.I.A.S. S.p.A. company

The purpose of this document is the transfer of the areas that will host the works referred to in the contract

### GIVEN THAT

- a) S.I.A.S. S.p.A. has the availability of the area subject of the works;
- b) The promoter/customer \_\_\_\_\_ is currently the assignee of the area highlighted in the attached plan;

### AND WHEREAS

1. All the preparations needed, as defined by D.Lgs. 81/08, will be entrusted to promoter/customer;
2. That area will be appropriately segregated, protected and equipped with appropriate signs, under responsibility of the promoter/customer;
3. The promoter/customer will use only the delimited area, as visible in the attached plan;
4. Transit to any work areas and the traffic of emergency vehicles must always be guaranteed;
5. The promoter/customer will ensure that access to the areas remains forbidden to vehicles unrelated to their activities (except for the vehicles above) and will ensure the continuous presence of persons who direct the traffic, necessary to report the maneuvers of the vehicles engaged in the work described above [ where necessary];
6. The promoter / customer will take all precautions in order to adequately protect the common parts traveled to get to their area in order to avoid possible damage.

### EMERGENCY MANAGING

#### THE PROMOTER/CUSTOMER DECLARES

- to assume all charges regarding the use of the area granted in use;
- to assume responsibility for the safety management of the workers and the public that may be present, adopting all the necessary prevention and protection measures, pursuant to D.Lgs 81/08 and D.M 10/03/98;
- to assume responsibility for the emergency management, pursuant to D.Lgs 81/08;
- that for this purpose, an insurance policy will be stipulated with a leading insurance company.

#### ALL THIS PREMISED AND CONSIDERED

- having regard to any interference risks associated with the work described above about the activities in the work area, and not detecting significant criticalities that prevent the regular performance of the activities,
- noted and valued the general regulation of the Autodrome,

the area is therefore transferred between the subjects as established.

As written above, the Employer Delegate of S.I.A.S. S.p.A. AUTHORIZES THE TRANSFER OF THE AREAS DESCRIBED ABOVE AND PRESCRIBES to be informed of any changes to what has been agreed for approval and their subsequent coordination.
